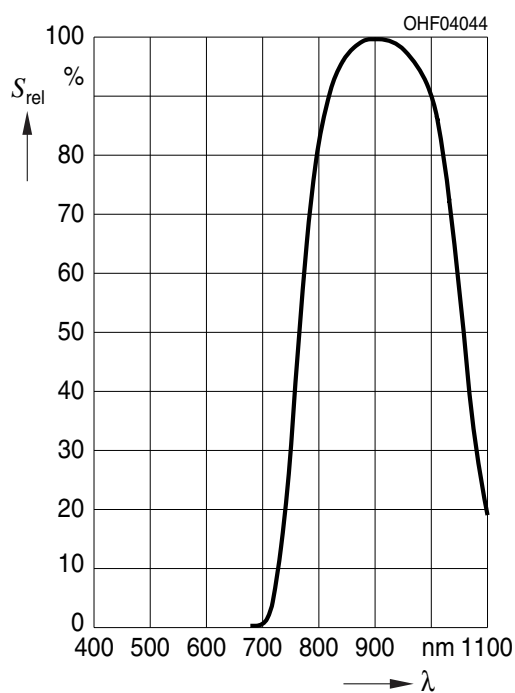

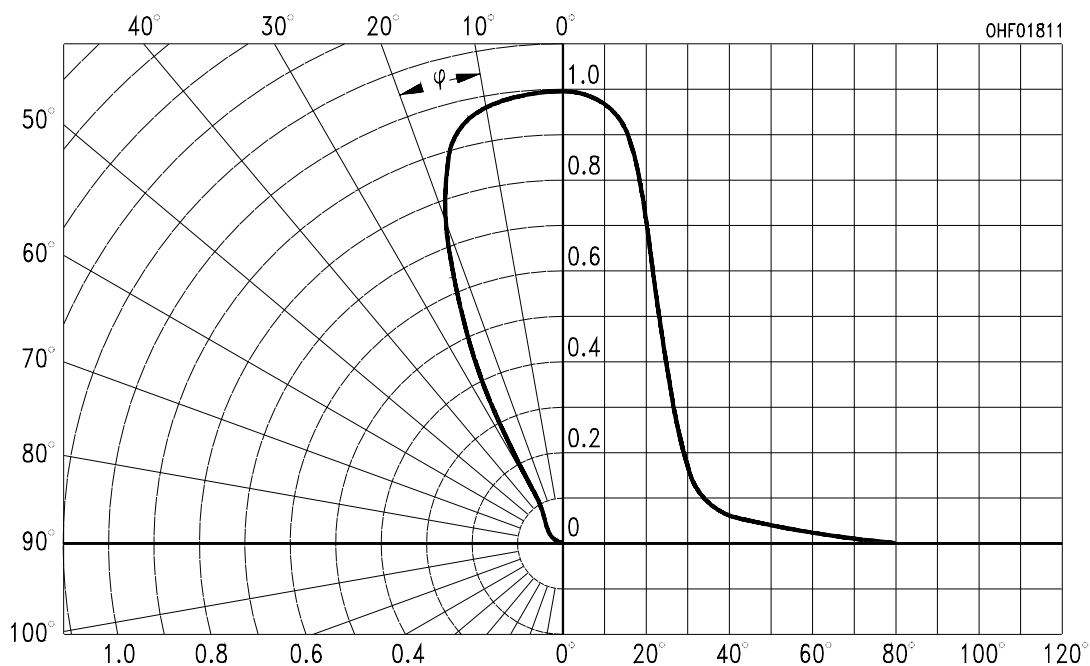

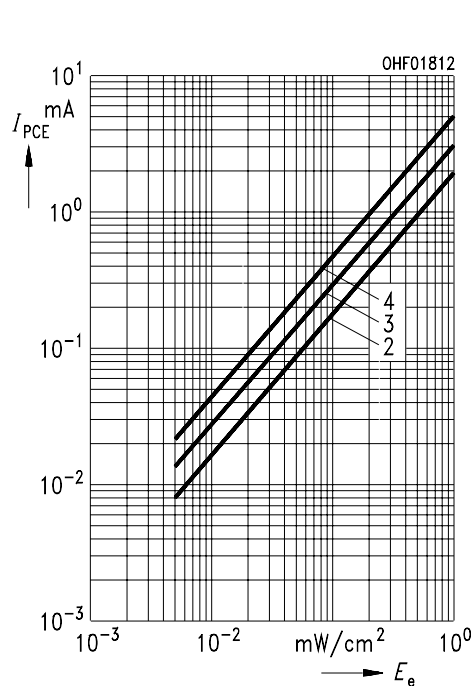
Directional Characteristics ^{4), 5)}

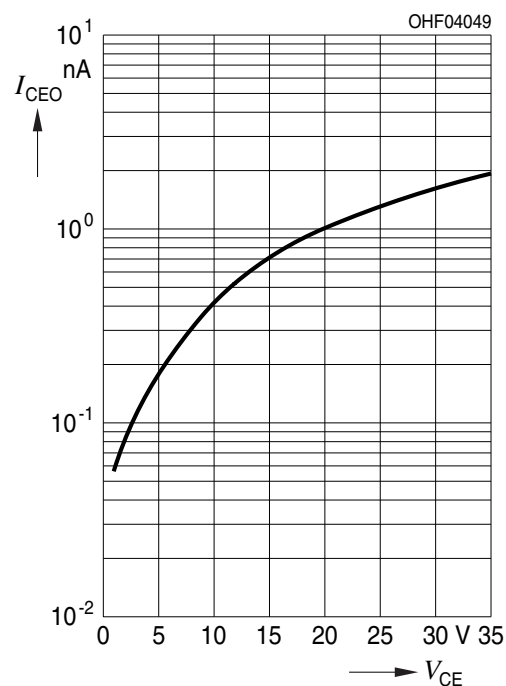

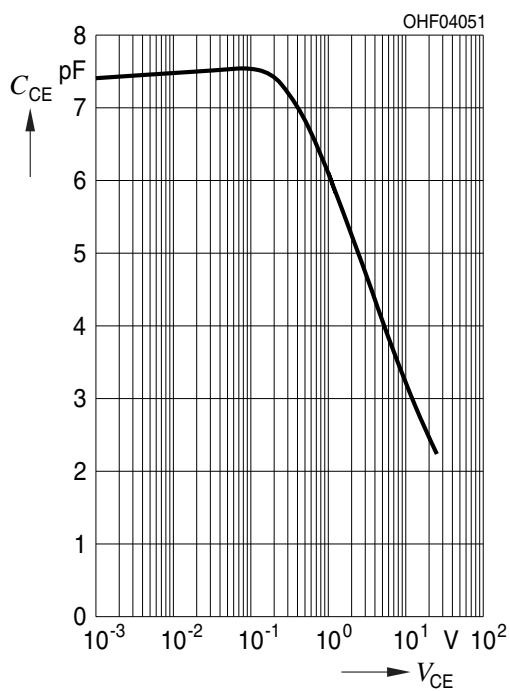

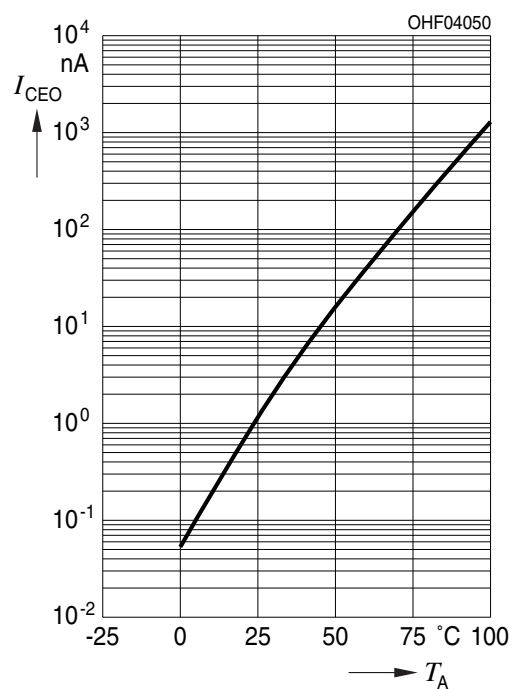

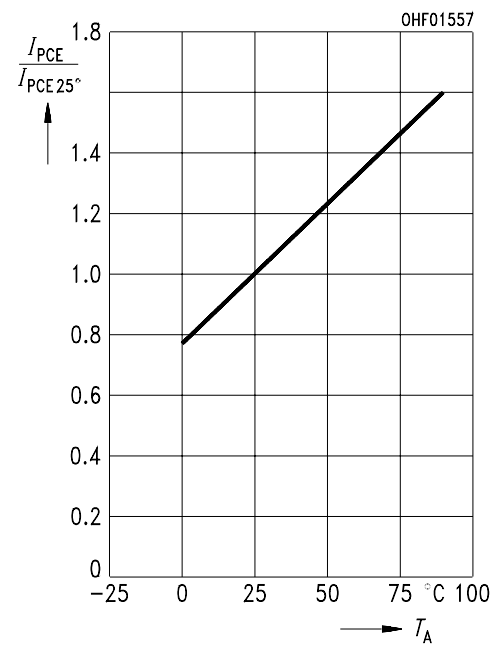

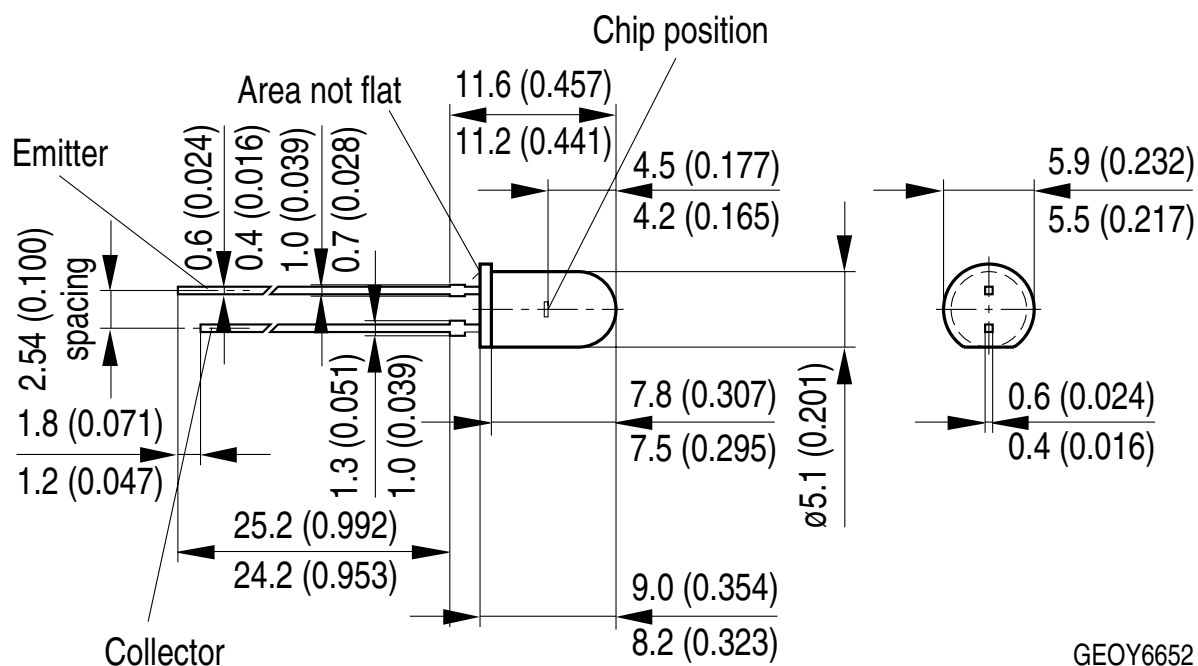


Photocurrent ⁴⁾

Dimensional Drawing ⁶⁾



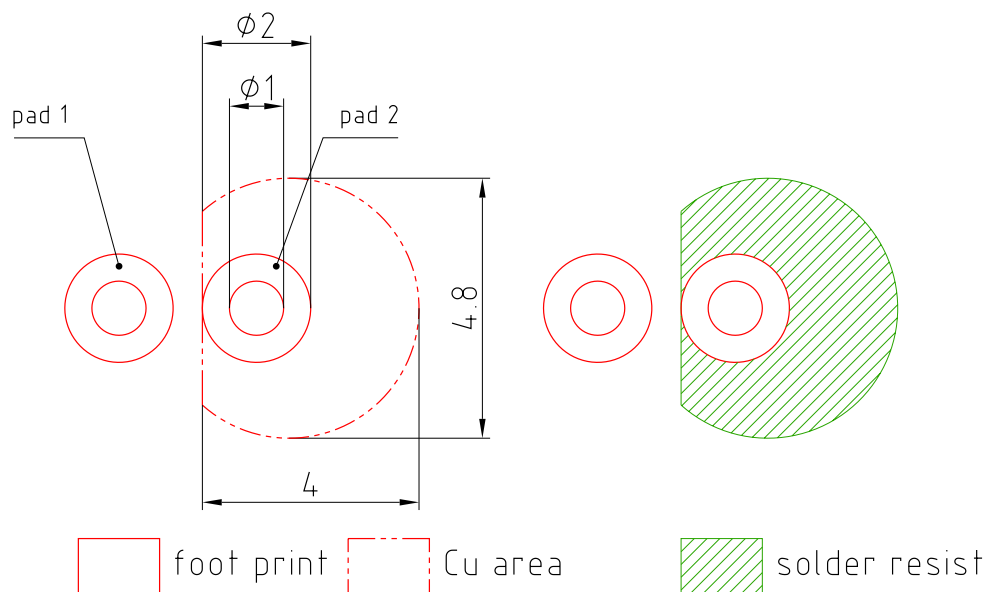

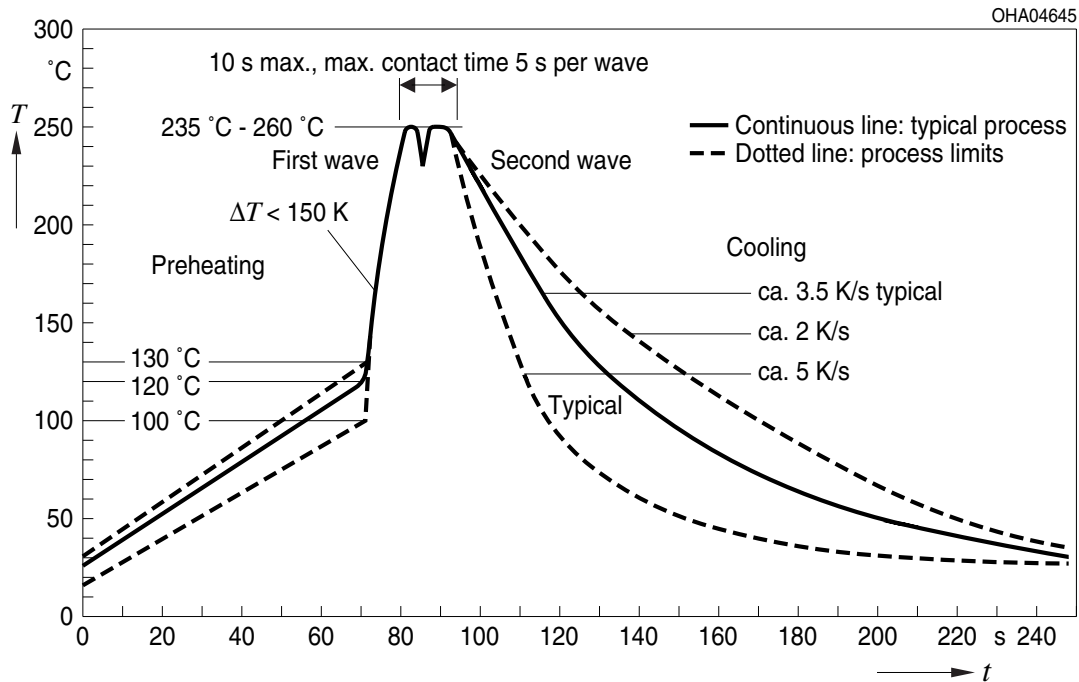
